Kobre & Kim Earns Top Recognitions in Chambers USA New York Rankings

Kobre & Kim and several lawyers have been recognized in the latest Chambers USA rankings for New York, placing among the top firms and lawyers in several categories for commercial, white-collar and financial litigation.

Litigation: General Commercial: Highly Regarded

Kobre & Kim placed in Band 1 for this category.

Chambers describes the firm's "prominent" practice as providing "individual and institutional clients with top-flight representation in high-profile commercial disputes as well as criminal and regulatory investigations."
